

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Board of Commissioners of Upper Allen Township, Cumberland County, Pennsylvania shall hold a public hearing to receive testimony and consider proposed ordinances to: (1) repeal and replace the Code of Upper Allen Township Chapter 214, Stormwater Management Ordinance, Article I – Article X, and (2) amend Ordinance 721 of Upper Allen Township, Section I, Definitions; Section 5, Prohibition of Illegal Discharges; Section 14, Appeal of Notice of Violation; and Section 20, Criminal Prosecution. The public hearing shall take place on February 1, 2023 at 6:00 p.m. at the Upper Allen Township Municipal Building, 100 Gettysburg Pike, Mechanicsburg, Pennsylvania 17055. The regularly scheduled Board of Commissioners' meeting for Wednesday, February 1, 2023 at 6:30 P.M., will commence after the close of the public hearing. The Board of Commissioners, at such time as the regularly scheduled meeting begins at the Upper Allen Township Municipal Building, shall consider for enactment and, if approved by formal action, adopt and enact the proposed ordinance.

The Township is seeking to repeal and replace Chapter 214, titled Stormwater Management Ordinance, to include Article I, General Provisions; Article II, Definitions; Article III, Stormwater Management Standards; Article IV, Stormwater Management Site Plan Requirements; Article V, Construction Inspections; Article VI, Operation and Maintenance; Article VII, Fees and Expenses; Article VIII, Prohibitions; Article IX, Enforcement and Penalties; and Article X, References; enacting a Stormwater Management ordinance that is consistent with the PA Department of Environmental Protection's (DEP) current 2022 Model Ordinance and incorporating DEP's minimum standards for process and administration. The Township also seeks to amend Ordinance 721 of Upper Allen Township, Section I, Definitions; Section 5, Prohibition of Illegal Discharges; Section 14, Appeal of Notice of Violation; and Section 20, Criminal Prosecution, so that it is consistent with Chapter 214, Stormwater Management Ordinance.
