

**NOTICE IS HEREBY GIVEN THAT THE BOARD OF COMMISSIONERS OF UPPER ALLEN TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA, WILL CONSIDER THE ENACTMENT AND ADOPTION OF AN AMENDMENT TO THE UPPER ALLEN TOWNSHIP CODE, CHAPTER 181 (PEACE AND GOOD ORDER) AND CHAPTER 217 (STREETS AND SIDEWALKS), AT A MEETING OF SAID BOARD TO BE HELD ON DECEMBER 20, 2023, AT 6:30 P.M. AT THE TOWNSHIP OFFICES, 100 GETTYSBURG PIKE, MECHANICSBURG, PENNSYLVANIA.**

**NOTICE IS HEREBY GIVEN** that the Board of Commissioners of Upper Allen Township, Cumberland County, Pennsylvania, shall consider for adoption and enactment, and if approved by formal action, adopt and enact an amendment to the Upper Allen Township Code, Chapter 181 (Peace and Good Order), including Sections 181-1 (Prohibited acts) and 181-2 (Violations and penalties); and incorporating Article II for the adoption of a nuisance noise ordinance; and amending Chapter 217 (Streets and sidewalks), Section 217-4 (Issuance of Permits; applicability), at their regular meeting scheduled for December 20, 2023 at 6:30 p.m., prevailing time, at the Upper Allen Township Municipal Building, 100 Gettysburg Pike, Mechanicsburg, Cumberland County, Pennsylvania 17055.

A brief summary of the proposed Ordinance amendment is as follows:

AN ORDINANCE OF THE TOWNSHIP OF UPPER ALLEN, CUMBERLAND COUNTY, COMMONWEALTH OF PENNSYLVANIA, PROVIDING FOR THE AMENDMENT OF THE PEACE AND GOOD ORDER ORDINANCE OF UPPER ALLEN TOWNSHIP, AS CODIFIED AT CHAPTER 181 OF THE TOWNSHIP CODE, PROVIDING FOR ARTICLE I (PROHIBITED ACTS) AND RELOCATION OF CERTAIN SECTIONS WITHIN ARTICLE I; PROVIDING FOR ARTICLE II (NOISE DISTURBANCE), TITLE ( §181-2.1), PURPOSE (§181-2.2), SCOPE (§181-2.3), DEFINITIONS (§181-2.4), LIMITS OF NOISE DISTURBANCE (§181-2.5), MAXIMUM PERMISSIBLE SOUND LEVELS (§181-2.6), EXEMPTIONS (§181-2.7), WAIVERS (§181-2.8), RESERVED SECTION (§181-2.9), ENFORCEMENT (§181-2.10), VIOLATIONS AND PENALTIES (§181-2.11), AND CONFLICTING REGULATIONS (§181-2.12); AND FOR THE AMENDMENT OF A SECTION WITHIN THE STREETS AND SIDEWALK ORDINANCE, AS CODIFIED AT CHAPTER 217 OF THE TOWNSHIP CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

SECTION I. Add new Article I, Prohibited Acts to Chapter 181.

SECTION II. Renumber existing §181-1. (Prohibited acts) to §181-1.1 and relocate within Article I.

SECTION III. Delete existing §181-.1.C.

SECTION IV. Renumber existing §181-2 (Violations and penalties) to §181-1.2 and relocate within Article I.

SECTION V. Add new Article II, Noise Disturbance to Chapter 181.

SECTION VI. Amend §217-4.E. within Chapter 217 (Streets and sidewalks) to cross-reference an amended subsection within Chapter 181.

SECTION VII. Provides for repeal of ordinances and part of ordinances inconsistent with the amendment.

SECTION VIII. Provides for severability.

SECTION IX. Provides an effective date.
